

The following promotion is intended for participants in the United States only, and will be governed by United States laws. Do not proceed in this promotion if you are not eligible or not currently located in the United States. Further eligibility restrictions are contained in the official rules below.

MARIA'S KNIGHT OUT PAJAMA CONTEST

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE ENTRANT'S CHANCE OF WINNING.

1. HOW TO ENTER

- a. These rules govern the MARIA'S KNIGHT OUT PAJAMA CONTEST promotion (the "Promotion"), which is being conducted by KOOL -FM (the "Station"). The Promotion will be conducted on Saturday, July 15, 2017 (the "Promotion Date").
- b. To participate in the Promotion, entrant must attend the KOOL Maria's Knight Out at Mountain Shadows at 5445 E Lincoln Dr, Paradise Valley, AZ 85253 on the Promotion Date beginning at 10:45 p.m. Mountain Standard Time ("MST") and ending at 11:00 p.m. MST (the "Entry Period"). To enter, all interested contestants must enter the preliminary pajama contest which will be held on the Promotion Date from 10:00 p.m. MST to 10:20 p.m. MST or until ten (10) Finalists have been selected, whichever occurs first. Contestants who want to qualify for the pajama contest finals need to walk in front of the "Pajama Contest Check-In Table" on-site one (1) at a time (unless the pajama is a group pajama). Group pajamas will be permitted. Contestants must provide the Station with their name and mobile phone number. At this time, the contestants will be judged by Station staff based on their pajama's creativity, originality, complexity, and execution of the pajama. The judges will select in their sole discretion up to ten (10) Finalists based on the criteria above. Qualifying ends once ten (10) Finalists have been selected or at 10:20 p.m. MST, whichever occurs first. The selected Finalists will be notified via a phone call to the phone number they provided at approximately 10:30 p.m. MST and will be invited to participate in the Pajama Contest at 10:45 p.m. MST. All selected Finalists will be required to complete an official entry form with their first and last name, complete address including zip code, telephone number, and date of birth. Participation is subject to confirmation of eligibility.
- c. The Pajama Contest will begin at approximately 10:45 p.m. MST. All selected Finalists must report to the main stage by 10:40 p.m. MST to check in and receive a registration number. Finalists that do not check in by 10:40 p.m. MST will be automatically disqualified and an alternate Finalist will not be selected. Each Finalist will be presented on stage based on the number they received

when they registered. The Finalist with the loudest crowd response as measured at the sole and absolute discretion of the Station will be deemed the winner for the Grand Prize.

- d. The Station, in its sole discretion, reserves the right to disqualify any contestant if their behavior or appearance contains illegal, indecent or otherwise offensive material. All contestants must remain fully clothed, meaning that a woman's breasts and all genitals remain fully covered. Nudity, profanity, and vulgarity are prohibited and will result in immediate disqualification. It is at the Station's sole and absolute discretion to disqualify any contestant who is deemed to have broken the rules of the Promotion for any reason. No nudity, or behavior which is deemed at the sole discretion of the Station to be unsuitable for public display, broadcast, or posting on the Station's website and affiliated CBS Radio websites (i.e., entries must be radio clean). Masks may only be worn inside the venue. Weapons accompanying costumes must not look authentic and must be easily recognizable as a toy representation. No guns (including toys) of any kind allowed. Contestants that do not comply with these rules will not be eligible for the Promotion.
- e. There will be up to a total of one (1) Prize winner selected in the Promotion.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are legal U.S. residents 21 years of age or older at the time of entry and who reside in Arizona. Void everywhere else and where prohibited or restricted by law. Employees, officers, directors and agents of Mountain Shadows, the Station, CBS Radio Inc., each of their respective parents, subsidiaries, and affiliates, the Station's advertising and promotion agencies, and participating sponsors or prize suppliers (collectively, the "Promotion Entities") and other radio stations in the Station's market, the members of their immediate families (spouses, parents, children, and siblings, regardless of where they reside) and those living in the same household of each (whether related or not), are ineligible to enter or win. This Promotion is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects, and entrant agrees to waive any right to claim ambiguity in the Promotion or Official Rules, except where prohibited by law.
- b. Only one (1) winner per household is permitted in this Station-conducted promotion.
- c. The winner(s) may be required to present valid government-issued photo identification and must provide winner's complete address, date of birth and phone number to claim a prize(s).

- d. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.

3. PRIZES

- a. Up to one (1) Prize will be awarded in this Promotion. The Prize consists of the following:
 - i. Five hundred dollars (\$500) awarded in the form of a check made payable to the Prize winner upon confirmation of eligibility.
 - ii. The Approximate Retail Value of the Prize is \$500.00.

Prize(s) is subject to availability. Certain restrictions may apply. Winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize(s). The Prize(s) is awarded as is. The winner must sign a Publicity and Liability Waiver Release form in order to claim Prize(s).

The cash portion of the Prize will be awarded in the form of a check issued by CBS Radio which will be mailed to the winner(s). Check will not be awarded, processed or mailed until winner(s) has claimed the prize at the Stations, presented all required documentation, and signed all required releases and tax forms. Check will be mailed approximately between ten (10) and fourteen (14) weeks after the Stations receive all required paperwork back from the winner(s). Prize checks will be mailed to the winner's address as provided in the IRS Form W-9 completed by the winner.

In the case of a group pajama, prize will be awarded only to the person who checked-in and filled out the official entry form with Station personnel for the Pajama Contest, and not the entire group.

- b. No more than the stated number of prizes specified in these official rules will be awarded. All prizes or prize certificates must be claimed at the office of the Station at the address below during regular business hours. The winner will forfeit any prize(s) or prize certificate(s) not claimed within ten (10) days of winning. In the event that a prize or prize certificate is mailed or shipped to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize(s) or prize certificate(s).
- c. Prize(s) is not transferable, and no substitution, assignment or cash equivalent of prize(s) is permitted, except by the Station (solely at its discretion), which reserves the right to substitute a prize or prize portion with another prize or prize portion of greater or equal value. The prize(s) are expressly limited to the item(s)

listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Promotion Entities are not responsible for winners' limitations that prevent acceptance or use of prize(s). The Prize(s) is provided as is. Entrants acknowledge that the Promotion Entities have not made, and are not in any manner responsible or liable for, any warranties, representations or guarantees, and hereby disclaim any and all warranties, expressed or implied, whether by contract or law, concerning any prize, including without limitation, implied warranties of quality, merchantability, mechanical condition or fitness for a particular purpose, with the exception of any standard manufacturer's warranty that may apply. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Promotion are final.
- b. Up to one (1) winner will be selected on Saturday, July 15, 2017, at approximately 11:00 p.m. MST as described above. The Finalist who receives: the highest score from the judges will win the Grand Prize. In the event of a tie, ties will be broken by crowd response. The Finalist with the loudest crowd response at the sole and absolute discretion of the Station will be deemed the winner for the prize.
- c. Winners will be notified on-site at the conclusion of the Pajama Contest on Saturday, July 15, 2017, at approximately 11:00 p.m. MST.
- d. Entrants need not listen to the Station but must be present to enter and win.
- e. Prize(s) will be awarded only upon confirmation of eligibility and completion of all requisite releases. Winners must execute and return any required affidavit of eligibility and/or liability/publicity release on-site within thirty (30) minutes of winning or prize will be forfeited and an alternate winner will not be selected. If a winner has not reached the age of majority in his/her state of residence, the prize(s) will be awarded in the name of his/her parent or legal guardian. If a potential winner(s) cannot be contacted, fails to sign and return the required fully-executed affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize(s).

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner(s). The winner(s) may be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize(s) and will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize(s) valued at \$600 or more or for any prizes awarded by the Station (or any

other CBS Radio station in Station's market) in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize(s). Such winnings of \$600 or more will be reported to the IRS.

- b. Participation in the Promotion and/or acceptance of prize(s) constitutes entrant's and/or winner's (and guest's, if applicable) permission for the Station or its designees to interview the winner(s) (or guest(s), if applicable), to photograph, film and record each winner (or guest, if applicable), and to use in commerce and in any media, now or hereafter known, throughout the world, in perpetuity, his/her name, prize(s) won, hometown (city and state), biographic information, likeness, photograph, voice, audio or video recording and/or any statements made by him/her regarding the Station, the Promotion and/or its sponsor(s) for purposes of trade, publicity or promotion without notice or additional compensation, notification or permission, in perpetuity, except where prohibited by law. Each winner (and guest, if applicable) agrees to sign a publicity release confirming such consent prior to acceptance of the prize, except where prohibited by law
- c. Participation in the Promotion and/or acceptance of prize(s) constitutes entrant's and/or winner's (and guest's, if applicable) agreement to release, discharge, and hold harmless the Promotion Entities and their respective officers, shareholders, directors, employees, agents and representatives and all of their successors and assigns (collectively, the "Released Parties") from and against any and all claims or liability arising directly or indirectly from any prize(s) awarded and participation in the Promotion, including, but not limited to, personal injury, death or damage to or loss of property, which may occur in connection with, preparation for, travel to, or participation in the Promotion, or delivery, possession, acceptance and/or use or misuse of any prize or participation in any Promotion-related activity, including, but not limited to, any claims based on publicity rights, defamation, invasion of privacy and merchandise delivery.
- d. If for any reason this Promotion cannot be executed as planned, including but not limited to, as a result of infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Released Parties that corrupt or affect the security, administration, fairness, integrity or proper conduct of the Promotion, or if the Promotion is compromised or becomes technically corrupted in any way, electronically or otherwise, the Station reserves the right to cancel, terminate, suspend and/or modify the Promotion. If the Promotion is terminated before the original end date, the Station reserves the right, in its sole discretion to, to modify the procedure for selecting winner(s), unless the nature of the event giving rise to such termination renders it impossible to select winner(s).
- e. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Promotion or in the announcement of a prize(s); (ii) incorrect or inaccurate entry information, human

error, failure or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone or text message service outages, delays, busy signals, poor signals or signal interference, accidental disconnection or equipment malfunctions or any other technological problems or failures of any kind; or (vi) any cancellations, delays, diversions, substitutions or omissions whatsoever by any transportation providers or any other persons or entities providing any services to winner(s) (and guest(s), if applicable) including any results thereof such as changes in services or location necessitated by same. Further, the Released Parties are not responsible if any part of a Promotion prize cannot be awarded due to acts of God, acts of war, natural disasters, weather, acts of terrorism or other factors beyond the Released Parties' control.

- f. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins or any other methods may void that entrant's entries and that entrant may be disqualified. The use of any device to automate entry is prohibited. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, promotion entry services or proxies) will void all entries by that entrant at the Station's discretion. The Station's or its Promotion administrator's computer or telephone system is the official time keeping device for this Promotion. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address or (ii) is assigned to the text or mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Promotion. Failure to comply with the rules of the Promotion may result in an entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, the Station may disqualify that entrant from entering and/or winning this and any or all future Station-administered Promotions and seek damages to the fullest extent permitted by law.
- g. The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the Promotion, including, without limitation, the substitution of a prize(s) of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Promotion Entities, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Station reserves the right, but not the obligation, to cancel, terminate, suspend or modify the

Promotion and shall not be required to award a substitute prize(s). If any provision of these Official Rules is irrevocably inconsistent with any provision set forth on the Contest webpage, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.

- h. Except where prohibited, by entering the Promotion, each entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Promotion or any prize(s) awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in New York, NY; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event shall such costs include attorneys' fees; and (3) no punitive, incidental, special, consequential or other damages, including, without limitation, lost profits may be awarded (collectively, "Special Damages"), and (4) entrant hereby waives all rights to claim Special Damages and all rights to have any damages awarded multiplied or increased. New York law governs the interpretation and construction of these Official Rules and all aspects related thereto.
- f.
